Keeping in view the above facts and circumstances the representation of the petitioner is considered sympathetically and he is hereby transferred on his own request from GSSS Hareta, Distt. Hamirpur to GMS Kasla, U/C GSSS Bah Distt. Solan, H.P against vacancy. The representation of the petitioner is disposed of accordingly.
