In the matter of: CWP No. 3676/2023 titled as Rajesh Kumar Vs. State of H.P. & Others.

Whereas, Sh. Rajesh Kumar, TGT (NM) preferred CWP No. 3676/2023 titled as Rajesh Kumar, TGT(NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding his transfer from GSSS Banore, Distt. Sirmour to Una, against vacancy being a couple case. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 13-06-2023 when the Hon'ble High Court has passed the following orders:-

"Learned counsel for the State states that the said representation will be disposed of by the 2nd respondent within four weeks in accordance with law and decision taken by 2nd respondent shall be communicated to the petitioner."

In the compliance the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 24-07-2023. He attended the same and submitted his representation in this office on 24-07-2023 vide which he has requested that he has completed required tenure at his present place of posting at GSSS Banore, Distt. Sirmour, H.P and he further requested that he may be transferred to GHS Lower Andaura, GMS Rajpur Jaswan, GSSS Thathar, GSSS Kaloh, GSSS Guglehar, Distt. Una, H.P, against vacancy.

Whereas, from perusal of record, it has been found that the petitioner is working at GSSS Banore, Distt. Sirmour w.e.f. 20-11-2019 and has completed the normal tenure of three years. However, stations of his choice are not vacant at this stage and also there is no person who has completed his normal tenure. Therefore, after careful examination, it is decided that since the Department of Higher Education is going to make promotions to the post of School Lecturer (New) from amongst the eligible Trained Graduate Teachers in near future, hence the petitioner will be given posting at a suitable place as and when the vacancy arises. The representation of the petitioner is disposed of accordingly.
