Hamirpur against vacancy due to promotion of present incumbent.

From the perusal of the record, it reveals that Smt. Anuradha, TGT(Med), is presently working in GSSS Chobia (Bharmour) Distt. Chamba GHS (which fall under hard area/sub cadre), since 26th Feburary,2021. At present there is no vacancy in above said institutions mentioned by the petitioner. I find it appropriate to order that the petitioner may be adjusted against vacancies existing in future as per her choices mentioned in the representation. The representation accordingly disposed off.
