The Petitioner, Sh. Niranjan Singh,TGT(Med),filed CWP No. 4890/2023 titled as, Niranjan Singh Vs State of H.P. before the Hon'ble High Court of H.P. against his transfer from GSSS Pubowal (UNA) to GSSS Mamligh (SLN).The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 31st July, 2023,when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/ order:-

All this stage ,learned proxy counsel for the petitioner under instructions of original counsel sought permission to withdraw the present petition with liberty reserved to the petitioner to move a representation to the competent authority /respondent for his adjustment ,in accordance with law and in terms os Trasnfer Policy .Accordingly ,the present petition is disposed of as withdrawn with liberty as prayed for.Pending miscellaneous application(s),if any ,shall also stand disposed of.

As per direction of the Hon'ble High Court the petitioner was called for personel hearing on dated 24th September,2023,but he could not attend the same.The petitioner submitted her representation through mail wherein he has requested that he may be adjusted in GHS Fatehwal/GHS Bangarh/GSSS Nangal Khurd Distt. Una against vacancy due to promotion of present incumbent. The petitioner has further stated that his parents are suffering from various old age ailments and no one in the family to look after them.

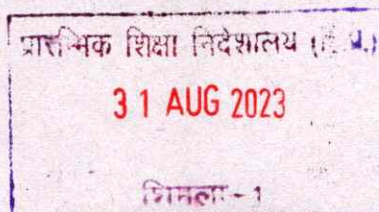
From the perusal of the record,it reveals that Sh. Niranjan Singh,TGT (Med) has been transferred from GSSS Pubowal Distt. Una to GSSS Mamligh (SLN) vice Smt. Sujata Sharma,TGT(Med) & vice-versa on the completion of normal tenure of three years as per policy,with the prior approval of the competent authority. However, being a Govt. employee and that too in a State cadre , request of the petitioner is not tenable. Moreover, in GSSS Mamligh(SLN), there are 98 students studying from class VI to X.. In the interest of the students post of TGT(Med) cannot be kept vacant. Therefore,keeping in view of the position stated above, the representation made by the petitioner can not be acceded to and hereby rejected and disposed of accordingly.
