Whereas, Sh. Avaden Singh, TGT (NM) preferred CWP No.: 5582/2023 titled as Avaden Singh Vs. The order be produced on the next date. List on 01-09-2023."

In compliance of the aforesaid orders of the Hon'ble High Court the petitioner has submitted his representation in this office on 30-08-2023 vide which he is serving since 11-03-2019 in GMS Kundi, U/C GSSS Sunara, Distt. Chamba, and he further requested that he may be transferred from GMS Kundi, U/C GSSS Sunara, Distt. Chamba to soft area in nearby Distt. Kangra, and Distt. Chamba, against vacancy/longer stayee. He has given five stations of his choice in the aforesaid representation.

Whereas, from perusal of record, it has been found that the petitioner is working at GMS Kundi, U/C GSSS Sunara, Distt. Chamba w.e.f. 11-03-2019 and has completed the normal tenure of three years. At present there is no post of TGT(NM) lying vacant in schools given by the petitioner in his representation. One Sh. Ashwani Kumar TGT(NM) is working in GHS Boungta, Distt. Kangra since 16-07-2020 and has completed his tenure of three years at his present place of posting. He has never served in hard/tribal area. The petitioner has requested in her representation that he may be transferred from GMS Kundi, U/C GSSS Sunara, Distt. Chamba Sub Cadre area to GHS Boungta, Distt. Kangra, against longer stayee. Keeping in view of the above position, the representation of the petitioner is considered sympathetically and he is hereby transferred from GMS Kundi, U/C GSSS Sunara, Distt. Chamba Sub Cadre area to GHS Boungta, Distt. Kangra, vice Sh. Ashwani Kumar, TGT(NM), with TTA/JT to Sh. Ashwani Kumar, TGT(NM). The representation of the petitioner is disposed of accordingly.
