**ORDER**

**In the matter :** CWP No. 5129/2023 titled as Smt.Deepa Chaudhary,TGT(Med)Vvs State of H.P.& others

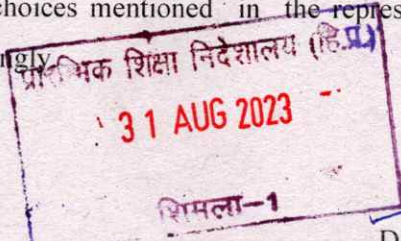
The Petitioner, Smt. Deepa Chaudhary,TGT(Med)) filed CWP No. 5129/2023 titled as, Deepa Chaudhary, TGT(Med),Vs State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from GHS Junas u/c GSSS Bonderi( Churah) Distt Chamba,H.P. (which fall under hard area /sub cadre )) to his choice of station after the completion of required tenure as per policy. The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 07<sup>th</sup> August,2023, when after hearing the matter,the Hon'ble High Court has disposed of the same with the following directions/ order:-

*" In view of the above submission,,this writ petition is disposed of by permitting the petitioner to make a fresh representation to respondent No.2 within a week from today,which shall be considered and decided by respondent No. 2/competent authority in accordance with law and applicable policy,within a period of three weeks,thereafter .The decision so arrived at shall also be communicated to the petitioner .*

*The writ petition stands disposed of in the above terms ,so also the pending miscellaneous application(s),if any.*

As per direction of the Hon'ble High Court the petitioner was called for personal hearing on dated. 24<sup>th</sup> August,2023,The petitioner attended the personal hearing on scheduled date and time. During personal hearing she has requested that she may be adjusted in GHS Sukker/ GSSS Hatwas /GSSS Dhugiari/GHS Kulthi / GSSS Tundi(CBA) against vacancy/due to promotion of present incumbent.

From the perusal of the record, it reveals that Smt. Deepa Chaudhary, TGT(Med), is presently working in GHS Junas(CBA)(which fall under hard area/ sub cadre), since 22<sup>nd</sup> Feburary, 2021. At present there is no vacancy in above said insititutions mentioned by the petitioner.I find it appropriate to order the petitioner may be adjusted against vacancies existing in future as per his choices mentioned in the representation of the petitioner is considered and disposed of accordingly.
