ORDER

In the matter of: CWP No. 5534/2023-titled as Parshottam Singh V/s State of Himachal Pradesh (Regarding Transfer).

Sh Parshottam Singh, TGT (Arts) has filed CWP No. 5534/2023 titled as Parshottam Singh V/s State of H. P., regarding transfer from GHS Sailli u/c GSSS Aura (Tribal area) District Chamba. The case was listed before the Hon'ble High Court of H.P. on 19-08-2023, when the same has been disposed of with the following orders:-

"In view of the above submission, this writ petition is disposed of by directing respondent N. 2/competent authority to decide the aforesaid representations of the petitioner (Annexure P-3 and P-4) in accordance with law and applicable policy, within a period of three weeks from today. The decision so arrived at shall also be communicated to the petitioner. The writ petition stands disposed of in the above terms, so also the pending miscellaneous application(s), if any."

In compliance to the aforesaid orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner i.e Sh. Parshottam Singh, TGT (Arts) was called for personal hearing and appeared before the undersigned on 26-08-2023. He has submitted representation, wherein he stated that he has completed normal tenure at his present place of posting (tribal area) and has requested for transfer from GHS Sailli u/c GSSS Aura, District Chamba to GSSS Lodhwan/GHS Badhuhi Khas u/c GSSS Badhuhi/GSSS Baranda/GSSS Gagwal, District Kangra or GMS Tritha u/c GSSS Nainikhad District Chamba, against vacancy.

From the perusal of record, it is found that Sh. Parshottam Singh, TGT (Arts) is working at GHS Sailli u/c GSSS Aura (tribal area) District Chamba since 19-11-2019 and has completed normal tenure at his present place of posting. At present post of TGT (Arts) are not lying vacant in GSSS Lodhwan/GHS Badhuhi Khas u/c GSSS Badhuhi/GSSS Baranda/GSSS Gagwal, District Kangra or GMS Tritha u/c GSSS Nainikhad District Chamba. Keeping in view the position stated above, representation of petitioner i.e Sh. Parshottam Singh, TGT (Arts) can not be considered at this stage due to non vacancy. Hence, representation made by the petitioner is hereby rejected and disposed of accordingly.
