"In view of the above submission, this writ petition is disposed of by directing respondent No. 2/competent authority to decide the aforesaid representation of the petitioner dated 07.07.2023 (Annexure P-1) in accordance with law and applicable policy, within a period of three weeks from today. The decision so arrived at shall also be communicated to the petitioner.

Govind Ram, TGT (Arts) is working in GHS Nalan, District Mandi since 09-02-2010 and has completed his normal tenure at his present place of posting, but he is Locomotor Disable person with 48% disability.

Keeping in view the position stated above, representation of petitioner i.e Ms. Lata Kumari, TGT (Arts) can not be considered at this stage due to non vacancy. Hence, representation made by the petitioner is hereby rejected and disposed of accordingly.
