ORDER

In the matter of: CWP No: 6374/2023-titled as Sanjeev Kumar V/s State of Himachal Pradesh (Regarding Transfer).

Sh. Sanjeev Kumar, TGT (Arts) has filed CWP No. 6374/2023 titled as Sanjeev Kumar V/s State of H. P., regarding transfer from GSSS Somanachhani District Mandi. The case was listed before the Hon'ble High Court of H.P. on 13-09-2023, when the same has been disposed of with the following orders:-

"Learned counsel for the petitioner submits that petitioner's representation seeking transfer from hard area to soft area of his choice was turned down by respondent No. 2 on 11-08-2023 (Annexure P-2) on the ground that the stations of choice opted by the petitioner were not vacant. Learned counsel further submits that the petitioner is ready and willing to furnish fresh representation detailing therein the stations of his choice where he can be accommodated including certain vacancies which are to arise in near future. Let him do so.

In case the petitioner furnishes such a representation then the same shall be considered & decided in light of the comprehensive policy keeping in view the fact that the petitioner has completed his normal tenure in a hard area. The decision so taken be placed on record by the next date.

In compliance to the aforesaid orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner i.e Sh. Sanjeev Kumar, TGT (Arts) has submitted fresh representation, wherein he stated that he may be adjusted at GHS Sahwal u/c GSSS Bohni, GHS Jhatwar u/c GSSS Lambloo, GSSS Tauni Devi, GMS Chalokhar u/c GSSS Nareli District Hamirpur or GSSS Kot Hatli, District Mandi.

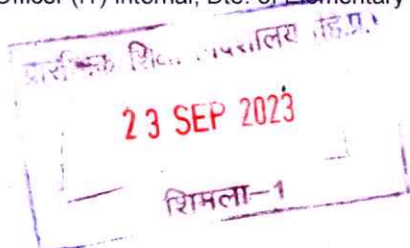
From the perusal of record, it is found that Sh. Sanjeev Kumar, TGT (Arts) is working at GSSS Somanachani District Mandi since 09-11-2016 and has completed normal tenure at his present place of posting. At present post of TGT (Arts) are not lying vacant in above mentioned school. Therefore, after careful examination, it is decided that since the Department of Higher Education is going to make promotions to the post of School Lecturer (New) from amongst the eligible Trained Graduate Teachers in near future, hence the petitioner will be given posting at a suitable place as and when the vacancy arise. Hence, representation made by the petitioner is hereby disposed of accordingly.
