

Whereas, Sh. Yogesh Kumar, TGT (NM) preferred CWP No. 4730/2023 titled as Yogesh Kumar Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GMS Teppa, U/C GSSS Devikothi, Distt. Chamba difficult and hard area to station of his choice in Distt. Kangra and Distt. Mandi. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 24-07-2023 when the Hon'ble High Court has passed the following orders:-

"4. In view of the above submissions, the instant writ petition is disposed of by directing respondent No.2 considered and decided the aforesaid representation of the petitioner, in accordance with law and applicable transfer policy, within a period of two weeks from today, by passing a reasoned order, which shall be communicated to the petitioner. Pending miscellaneous application(s), if any, shall also stand disposed of."

Whereas, in the compliance to the orders passed by the Hon'ble High Court petitioner was called for personal hearing on 24-08-2023 and he attended the same. At the time of personal hearing the petitioner has submitted that he has completed more than three year stay at his present place of posting i.e. GMS Teppa, U/C GSSS Devikothi, Distt. Chamba, which is a difficult/hard area. He has further requested that he may be transferred to GSSS(Girls) Paprola, Distt. Kangra, against vacancy likely to be caused due to retirement of present incumbent on 31-10-2023 and against vacancy or longer stayee in GMS Dharer, GSSS Deol, GMS Malghota, Distt. Kangra and GSSS Shimash, Distt. Mandi.

From perusal of record, it has been found that the petitioner has been working in GMS Teppa, U/C GSSS Devikothi, Distt. Chamba since 18-11-2019 and has completed more than three years stay there. However, stations of his choice are not vacant at this stage and also there is no person who has completed his normal tenure. One post of TGT(NM) is going to be vacant due to retirement of present incumbent at GSSS(Girls) Paprola, Distt. Kangra on 31-10-2023. Keeping in view the above facts and circumstances, the representation of the petitioner is considered sympathetically and he is hereby transferred without TTA/JT from GMS Teppa, U/C GSSS Devikothi, Distt. Chamba to GSSS(Girls) Paprola, against vacancy likely to be caused due to retirement of present incumbent 31.10.2023. These orders will be implemented after the retirement of present incumbent on 31.10.2023. The representation of the petitioner is disposed of accordingly.
