Whereas, Pankaj Rani, TGT (NM) preferred CWP No. 5025/2023 titled as Pankaj Rani Vs. State of H.P. before the Hon'ble High Court of H.P. against her transfer from GMS Haloonda, U/C GSSS Sandhi, Distt. Chamba to Distt. Kangra, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 04-08-2023 when the Hon'ble High Court has passed the following orders:-

*"4. In view of the above submissions, the instant writ petition is disposed of by permitting the petitioner to make a fresh representation to the competent authority / respondent No. 2 within a period of one week from today, who shall in turn, consider and decided the same, in accordance with law and applicable transfer policy, within a further period of three weeks by passing a reasoned order, which shall also be communicated to the petitioner. Pending miscellaneous application(s), if any, shall also stand disposed of."*

In compliance of the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 29-08-2023. She attended the same and submitted her representation in this office on 29-08-2023 vide which She has requested that She has completed required tenure at her present place of posting at GMS Haloonda, U/C GSSS Sandhi, Distt. and She further requested that She may be transferred to Distt. Kangra, against vacancy/ longer stayee. She has given five stations of her choice in the aforesaid representation.

Whereas, from perusal of record, it has been found that the petitioner is working at GMS Haloonda, U/C GSSS Sandhi, Distt. Chamba w.e.f. 22-11-2019 and has completed the normal tenure of three years. At present there is no post of TGT(NM) lying vacant in schools given by the petitioner in her representation. One Sh. Ajay Kumar, TGT(NM) is working in GMS Kangreri, U/C SJS GSSS Makroli, Distt. Kangra since 01-07-2019 and has completed his tenure of three years at his present place of posting. The petitioner has requested in her representation that She may be transferred to GMS Kangreri, U/C SJS GSSS Makroli, Distt. Kangra, against longer stayee. Keeping in view of the above position, the representation of the petitioner is considered sympathetically and She is hereby transferred from GMS Haloonda, U/C GSSS Sandhi, Distt. Chamba to GMS Kangreri, U/C SJS GSSS Makroli, Distt. Kangra, vice Sh. Ajay Kumar, TGT(NM), with TTA/JT to Sh. Ajay Kumar, TGT(NM). The representation of the petitioner is disposed of accordingly.

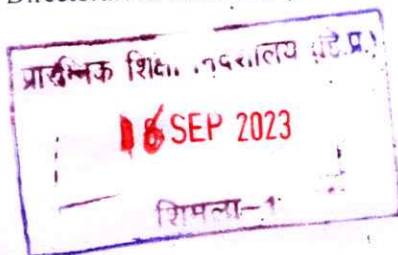
