Whereas, Sh. Rakesh Kumar, TGT (NM) preferred CWP No. 9397/2024- titled as Rakesh Kumar Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GMS Goway, U/C GSSS Dharchandna, Distt. Shimla (hard area) to nearby his native place in Distt. Kangra, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 05-09-2024 when the Hon'ble High Court has passed the following order

"3. This writ petition is accordingly disposed of with the direction that the representation filed by the petitioner be decided in light of the averments made therein within a period of four weeks from today. pending miscellaneous application(s), if any also stand disposed of accordingly."

In the compliance of the aforesaid orders passed by the Hon'ble High Court, the petitioner was called for personal hearing on 04-10-2024. He attended the same and submitted his representation in this office on 04-10-2024, vide which he has requested that he may be transferred from GMS Goway, U/C GSSS Dharchandna, Distt. Shimla (hard area) to nearby his native place in Distt. Kangra, H.P, against vacancy being caused due to retirement on 31-12-2024 at GSSS Kosri, Distt. Kangra, H.P / against longer stay by clubbing his/her previous stay radius of 30 Kms. .

Whereas, from perusal of record, it has been found that the petitioner is working at GMS Goway, U/C GSSS Dharchandna, Distt. Shimla, H.P. since 25-02-2021 and has completed the normal tenure of three years at present place of posting. The petitioner has given willingness for his transfer to the aforesaid school i.e GSSS Kosri, Distt. Kangra, H.P, against vacancy being caused due to retirement of present incumbent on 31-12-2024. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetic, and he is hereby transferred without TTA/JT from GMS Goway, U/C GSSS Dharchandna, Distt. Shimla, H.P to GSSS Kosri, Distt. Kangra, H.P, against vacancy being caused due to retirement of present incumbent on 31-12-2024 . These orders will be implemented after the retirement of present incumbent. The representation of the petitioner is disposed of accordingly.
