ORDER

In compliance to the orders passed by the Hon'ble High Court of Himachal Pradesh, in CWP No. 10270/2024 titled as Ajay Kumar, TGT (Arts) V/s State of H.P. on dated 17th September, 2024, the petitioner has submitted his fresh representation with the request to adjust either at GMS Jambukhala u/c GSSS Ajoli, GHS Bangran u/c GSSS Shivpur, ~~GHS~~ Amarkot or GHS Sirmouri Tal u/c GSSS Ajoli, District Sirmour, being a couple case.

On the perusal of record, it is revealed that Sh. Ajay Kumar, TGT (Arts) is working at GSSS Barwas (soft area) District Sirmour since 15-09-2022 and has not completed normal tenure at his present place of posting.

In this connection it is found that Sh. Ajay Kumar, TGT (Arts) is working at GSSS Barwas (soft area) District Sirmour wherein the enrollment of students is 21 (Aprx.) and one post of TGT (Med) is already lying vacant in the school. At present post of TGT (Arts) are not lying vacant at the schools given by the petitioner. As per provision contained in comprehensive guidelines Principles-2013 for regulating the transfer of State Government employees, it is specifically mentioned in Para 12.1 "All employees during their period of service will serve for at least single tenure in the Tribal/difficult/ Hard area and remote/ rural areas. Transfer to a particular place of choice cannot be claimed as a matter of right. It will be the discretion of the State Govt., to post/transfer any employee anywhere in the state, keeping in view of the administrative "exigencies/convenience." Therefore, being a State cadre Government employee, the request of the petitioner is not tenable and hereby rejected.
