Whereas, Sh. Naresh Kumar, TGT (NM) preferred CWP No. 10931/2024- titled as Naresh Kumar Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GMS Chaloga, U/C GSSS Kiri, Distt. Chamba, H.P. (hard area) to nearby his native place in Distt. Kangra, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 26-09-2024 when the Hon'ble High Court has passed the following order

*"3. This petition is accordingly disposed of with the direction that whenever general transfers are effected by the Education Department, the petitioner be posted out of the present station and preferably to a station of his choice if available or to some other nearby station on priority basis."*

In the compliance of the aforesaid orders passed by the Hon'ble High Court, the petitioner was called for personal hearing on 22-10-2024. He attended the same and submitted his representation in this office on 22-10-2024, vide which he has requested that he may be transferred from GMS Chaloga, U/C GSSS Kiri, Distt. Chamba, H.P (hard area) to nearby his native place in Distt. Kangra, H.P, against vacancy being caused due to retirement on 28-02-2025 at GMS Sard Bammi, U/C GSSS Kaloha, Distt. Kangra, H.P / against longer stay by clubbing his/her previous stay radius of 30 Kms. .

Whereas, from perusal of record, it has been found that the petitioner is working at GMS Chaloga, U/C GSSS Kiri, Distt. Chamba, H.P, since 14-03-2019, which is a hard/tribal area and has completed the normal tenure of three years at present place of posting. The petitioner has given willingness for his transfer to the aforesaid school i.e GMS Sard Bammi, U/C GSSS Kaloha, Distt. Kangra, H.P., against vacancy being caused due to retirement of present incumbent on 28-02-2025. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetic, and he is hereby transferred without TTA/JT from GMS Chaloga, U/C GSSS Kiri, Distt. Chamba, H.P to GMS Sard Bammi, U/C GSSS Kaloha, Distt. Kangra, H.P, against vacancy being caused due to retirement of present incumbent on 28-02-2025. These orders will be implemented after the retirement of present incumbent. The representation of the petitioner is disposed of accordingly.
