Chamba, H.P (hard area) to nearby his native place in Distt. Kangra, H.P, against vacancy being caused due to retirement on 28-02-2025 at GMS Sard Bammi, U/C GSSS Kaloha, Distt. Kangra, H.P / againat longer stay by clubbing his/her previous stay radius of 30 Kms.

Whereas, from perusal of record, it has been found that the petitioner is working at GMS Chaloga, U/C GSSS Kiri, Distt. Chamba, H.P, since 14-03-2019, which is a hard/tribal area and has completed the normal tenure of three years at present place of posting. The petitioner has given willingness for his transfer to the aforesaid school i.e GMS Sard Bammi, U/C GSSS Kaloha, Distt. Kangra, H.P., against vacancy being caused due to retirement of present incumbent on 28-02-2025. Keeping in view of the position stated above, the representation of the petitioner is considered sympatheticay, and he is hereby transferred without TTA/JT from GMS Chaloga, U/C GSSS Kiri, Distt. Chamba, H.P to GMS Sard Bammi, U/C GSSS Kaloha, Distt. Kangra, H.P, against vacancy being caused due to retirement of present incumbent on 28-02-2025. These orders will be implemented after the retirement of present incumbent. The representation of the petitioner is disposed of accordingly.
