In the matter of CWP No. 10722/2023 titled as Surender Klimar & Ors Vs. State of HP. decided on 10.09.2024.

## **ORDER**

Whereas, the petitioners filed CWP No. 10722/2023 titled as Surender Kumar (TGT) & Ors Vs State of HP. in the Hon'ble High Court of H.P. and Hon'ble court has disposed of the case with following orders:-

- "4. Learned counsel for the petitioners further submits that w.r.t. the grievances being raised in the present petition, representations dated 13.10.2023 stand made to the concerned authorities. The same are appended with the present petition as Annexure P-4(Colly).
- 5. Learned Addl. Advocate General submits that the representations so made by the petitioners, shall be decided within a period of four weeks from today. 6. In view thereof, present petition is disposed of, so also the pending application(s), if any."

After perusal of the record, it is found that the petitioners in CWP No. 10722/2023 titled as Surender Kumar & others Vs State of HP & Ors were initially appointed on contract basis under physically handicapped quota.

Whereas, the judgment passed in CWPOA No. 1077 of 2019 titled as Nitin Kumar Vs State of H.P. & anr. pertain to the Department of Women & Child Development H.P. and same has been implemented by the Department of Women & Child Development H.P. vide office order No. WCD-AC(1)-12/2012-Estt.(Court) dated 04.04.2023 (copy enclosed). The judgment passed in CWP No. 4299 of 2019 titled as Pushpa Devi & others Vs State of H.P. & others has also been implemented by H.P. University Shimla vide office order No. 6-2/2019-HPU (Estt.)- dated 06.10.2022 by regularizing the services of the petitioners (who were appointed on contract basis under physically handicapped quota) w.e.f. the date(s) of their initial joining on contract basis with all consequential benefits including counting the period for the purpose of seniority etc.

Whereas, similar matter of CWP No. 3957/2023 titled as Vinod Kumar Rana Vs State of H.P. was taken up with the Government vide letter No. EDN-H(2)B(2)3957/2023-TGTs-Vinod Kumar Rana dated 01.01.2024 & 22.03.2024 and the Government vide letter No.EDUC-E05/21/2023 dated 24.05.2024 conveyed the approval to implement the judgment dated 02.08.2023 subject to final outcome of the further legal remedy, in any, being exercise by the State. Accordingly the Department implement the judgment of the Hon'ble High Court of H.P. vide office order No. EDN-H(2)B(2)3957/2023-CC dated 25.05.2024.

In view of above facts stated here in above and further approval conveyed by the Govt. vide letter NO. EDN-C-E(5)/5/2016-V-EDU-C dated 29.10.2024, the following petitioners are hereby considered deemed regular employee of the State with all consequential benefits w.e.f. the date of initial appointment/joining on contract basis as TGT (Arts/NM/Med), subject to final outcome of any legal remedy. If any, exercised by the State:-
