Board of School Education Dharamshala Distt. Kangra are hereby offered appointment as Trained Graduate Teacher (Medical) purely on contract basis on the fixed salary of Rs.13900/-(10300+3600 grade pay+ 125 % of the grade pay of the post). Only annual increase @ 3 % of the minimum of the pay band plus grade pay is admissible. This increase of 3 % will not be given on progressive contractual amount without rounding off to next multiple of 10.
