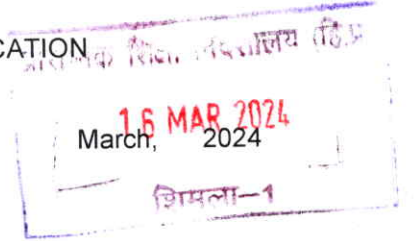

THESE TRANSFER ORDERS MAY BE ISSUED AFTER VERIFYING THE STAY OF THE CONCERNED TEACHERS (THREE YEARS.). IN CASE SHORT STAY IS NOT CONDONED THAN TRANSFER ORDER SHOULD BE REFERRED BACK BUT HIS STAY WITHIN THE RADIUS OF 30 KM. MAY ALSO BE TAKEN INTO ACCOUNT IN CASE OF CLUBBING.

1. These orders may be implemented in relaxation of ban on transfers.
2. If the incumbent has already served Sub-cadre/hard/tribal/difficult area in that event he/she may not be relieved again to areas ibid.
3. It must be ensured that the candidate is not specially abled.
4. It must be ensured that the incumbent is not on the verge of retirement.

5. The transfer orders of TGTs issued from hard area to soft area may not be implemented without joining of substitute.
6. If incumbent (s) who has/have not completed three years tenure in his/her present place of posting, transfer orders may not be implemented, if stay of the incumbent (s) not condoned.
7. All provisions as contained in O/M No:PER (AP-3) E(3)17/2021 dated 10.07.2013 "Comprehensive Guiding Principles 2013---- for regulating the transfer of State Govt. Employees at point No.5" concession to certain categories of employees and 5.5. of O/M dated 17.9.15 must be adhered strictly.

1. The Dy. Director of Elementary Education as mentioned above.

The Principals/ Headmasters as mentioned above with the directions that the incumbent working under your establishment be relieved immediately failing which disciplinary action will be initiated against the defaulter under the rules. If the controlling officer does not comply with this procedure the salary of the surplus incumbent will be drawn from the salary of controlling officer.
