In the matter of: CWP No. 8789/2023 -titled as Vikram Singh Vs. State of H.P. & Others.

Whereas, Sh. Vikram Singh, TGT (NM) preferred CWP No. 8789/2023 titled as Vikram Singh, TGT(NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding his transfer from GMS Koon, U/C GSSS Balag, Distt. Mandi, H.P to nearby home station in Distt. Mandi. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 26-12-2023 when the Hon'ble High Court has passed the following orders:-

*"9. In this Background, this Court, as prayed for by learned counsel for the petitioner, permits the petitioner to make a representation, indicating five stations of choice in more than one Distt. in terms of Clause 16.1 of the transfer policy, within a week from today; with further directions to the respondent No. 2- Director Elementary Education, H.P, Shimla, to examine the case of the petitioner and to pass appropriate orders in the light of Clauses 12,15 & 16.1 of the transfer policy after giving personal hearing to the petitioner , within three weeks from today. As aforesaid, the instant writ petition as well as the pending miscellaneous application(s), if any, shall also stands disposed of, accordingly."*

In compliance with the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 06-04-2024. He attended the same and submitted his representation in this office, vide which he has requested that he has completed required tenure at his present place of posting i.e GMS Koon, U/C GSSS Balag, Distt. Mandi and he further requested that he may be transferred to nearby home station in Distt. Mandi, H.P against vacancy/ longer stayee by clubbing his/her previous stay .

Whereas, from perusal of record, it has been found that the petitioner is working at GMS Koon, U/C GSSS Balag, Distt. Mandi, H.P w.e.f. 16-11-2019 and has completed the normal tenure of three years. One Sh. Suresh Kumar, TGT(NM) is working at GHS Jhor, U/C GSSS Kapahi, Distt. Mandi, H.P since 29-09-2022. The petitioner has given willingness for his transfer to the aforesaid school against longer stay by clubbing his previous stay. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetically, and he is hereby transferred without TTA/JT from GMS Koon, U/C GSSS Balag, Distt. Mandi, to GHS Jhor, U/C GSSS Kapahi, Distt. Mandi, H.P, vice Sh. Suresh Kumar, TGT(NM), by clubbing his previous stay within radius of 30 Kms., with TTA/JT to Sh. Suresh Kumar, TGT(NM). The representation of the petitioner is disposed of accordingly.
