**ORDER**

In the matter of: CWP No. 2432/2022 titled as Ashwani Kumar Vs. State of H.P. & Others.

Whereas, Sh. Ashwani Kumar, TGT (NM) preferred CWP No. 2432/2022 titled as Ashwani Kumar Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GMS Thangarh u/c GSSS Maneoti Distt. Shimla to the station of his choice near his native place. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 09.05.2022 when the Hon'ble High Court has passed the following orders:-

" 3. Accordingly, without adverting to the merits of the case, we deem it appropriate to dispose of the writ petition with a direction to respondent No. 2, Director of Elementary Education, to dispose of the representation dated 02.03.2022 (Annexure P-4), moved by the petitioner, expeditiously, preferably within two weeks from the date of receipt of copy of this order. "

4. Pending miscellaneous application(s), if any, shall also stand disposed of. "

Whereas, petitioner submitted his representation to this office on 26.5.2022 vide which he has enclosed the copy of the aforesaid judgment. On the perusal of Annexure P-4 there is no post of TGT(NM) lying vacant in the school where the petitioner has requested to transfer him. However, the petitioner has given a fresh representation to this office on 3.8.2022 vide which he has requested to adjust him at GMS Randhala u/c GSSS Baha District Solan against vacancy.

From perusal of record, it has been found that the petitioner has been working at GMS Thangarh u/c GSSS Maneoti, Distt. Shimla since 11.3.2019 and has completed three years stay there. One post of TGT(NM) is lying vacant in GMS Randhala u/c GSSS Baha District Solan. Keeping in view the above facts and circumstances, the representation of the petitioner is considered sympathetically and he is hereby transferred without TTA/JT from GMS Thangarh u/c GSSS Maneoti District Shimla to GMS Randhala u/c GSSS Baha District Solan against vacancy, without TTA/JT. The representation of the petitioner is disposed of accordingly.

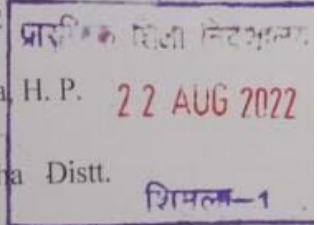
