ORDER

In the matter : CWP No. 4248/2023/2023 titled as **Rajender Kumar,TGT(Med)VS State of H.P. & others.**

The Petitioner, Sh. Rajinder Kumar ,TGT(Med) filed CWP No. 4248/2023 titled as, Rajender Kumar, TGT, (Med),versus State of H.P. before the Hon'ble High Court of H.P.regarding his transfer from GHS Naya u/c GSSS Shillai Distt. Sirmour (which fall under hard area) to his choice of station after the completion of required tenure as per policy. The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 03rd July,2023, when after hearing the matter,the Hon'ble High Court has disposed of the same with the following directions/ order:-

" In view of the above ,petitioner is directed and permitted to file fresh representation to trespondent No.2,the Director of Elementary Education /competent authority on or before 14th July,2023.In case such representation is preferred,a same shall be decided by the competent authority on or before 10th August 2023, by passing a speking and reasoned order,after affording opportunity of personal hearing to the petitioner ,if desired so.Order shall be communicated to the petitioner immediately thereafter.In case station(s)mentioned in the representation is/are lying vacant,then at least,oone of the such stations shall not be filled .if not already filled,till the decision of representation.

Petition is disposed of in aforesaid terms ,so also pending application(s),if any."

As per direction of the Hon'ble High Court the petitioner was called for personel hearing on dated 18th July,2023 .The petitioner attended the personal hearing on scheduled date and time.During personal hearing he has requested that he may be adjusted in GHS Kot u/c GSSS Saroh(Una)/ GSSS Saloa/ GSSS Hatwar /GSSS Panthera /GSSS Kandrouer Distt. Bilaspur against vacancy.

From the perusal of the record, it reveals that Sh. Rajender Kumar,TGT(Med), is presently working in GHS Naya u/c GSSS Shillai Distt. Sirmour , (which fall under hard area) since 04th October,2017 and has completed his normal tenure at present place of posting. I find it appropriate to transfer the petitioner to GSSS Saloa Distt. Bilaspur against vacancy.With these observations the representation of the petitioner is considered and disposed of accordingly.
