ORDER

CWP No. 7519/2023 titled as Smt. Anjana Kumari, TGT (Med) V/s State of In the matter: H.P. & others T(Med).

November, 2023

The Petitioner, Smt. Anjana Kumari, TGT(Med)) filed CWP No. 7519/2023 titled as, Anjana Kumari, Vs State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from GSSS Pressi Distt Mandi, H.P. (which fall under hard/difficult area) to station of her choice after the completion of required tenure as per policy. The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 09th October, 2023, when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/ order:- '

"Consequently, in view of above the present petition is disposed of with a direction to the respondents to decide the representation dated 07-08-2023 (Annexure P-1) exppediatiously, prefearably within a period of three weeks stricitly in terms of Comperhensive Guiding Principles wherein admittedly provision has been made to accommodate an employee at a station of his/her choice, if she has completed normal tenure at presentplace of posting in hard area.

Needless to say authority concerned , while doing the needful in terms of this order, shall afford opportunity of hearing to the petitioner and pass a speaking order thereafter.Liberty is reserved to the petitioner to file appropriate proceedings before appropriate court of law, if she still remains aggrieved."

As per direction of the Hon'ble High Court the petitioner was called for personal hearing on dated. 20th November, 2023. The petitioner attended the personal hearing on scheduled date and time. During personal hearing she has requested that she may be adjusted in GHS Kalahod Distt. Mandi against vacancy.

From the perusal of the record, it reveals that Smt. Anjana Kumari, TGT(Med), is presently working in GSSS Pressi (MND) since 29th September 2020 and has completed her normal tenure at present place of posting. At present there is no post of TGT(Med) lying vacant in the said institution mentioned by the petitioner. At present one post of TGT(Med) is lying vacant in GHS Binoul (Sadar) Distt. Mandi. I find it appropriate to transfer the petitioner to GHS Binoul (Sadar) Distt. Mandi against vacancy. With these observations the representation

of the petitioner is considered and disposed of accordingly.
