ORDER

In the matter : CWP No. 9459/2022 titled as Geeta ,TGT(Med)VS State of H.P. & others.

The Petitioner,Smt.Geeta ,TGT (Med), filed CWP No. 9459/2022 titled as Smt. Geeta,Vs State of H.P. before the Hon'ble High Court of H.P.regarding her transfer from GSSS Dhullara Distt, Chamba (which falls under hard /Tribal area) to her choice of station after the completion of required tenure as per policy.The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 30th Nov.2023, when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/ order:-

" In this background ,learned counsel for the petitioner submits that the petitioner submits that the petitioner shall be satisfied ,in case,direction is issued to the Respondent No.2-Director of Elementary Education ,Himachal Pradesh,to decide the representations dated 29-08-2023,Annexure P-1 and 11-10-2023,Annexure P-3,within a period of three weeks,with further directions to the aforesaid respondent to decide the representations dated 29-08-2023,Annexure P-1 and 11-10-2023,Annexure P-3 within two weeks thereafter after giving a personal hearing to the petitioner."

As per direction of the Hon'ble High Court the petitioner was called for personal hearing on dated. 12th December,2023. but she could not attended the same. The petitioner submitted her representation through advocate to the undersigned ,wherein she has requested the she may be adjusted in GMSSS Bhunter Distt. Kullu against vacancy likely to be caused due to retirement of present incumbent. She has further stated that she has undergone surgery and her husband is posted at Distt. Kullu and no one is there look after her.

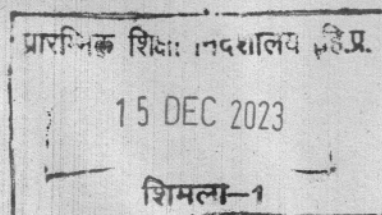
From the perusal of the record, it reveals that Smt.Geeta,TGT,(Med) has been working in GSSS Sali(CBA) since 23-10-2006 to 18-02-2021(PTA basis) after regularisation she is working in GSSS Dhullara (Mehla) Distt. Chamba since 23-02-2021 (both of the insititution fall under hard /Tribal area).I find it appropriate to transfer the petitioner to GMSSS Bhunter Distt. Kullu against vacancy being caused due to superannuation of present incumbent.i.e. Smt. Meenakshi Sharma,TGT(Med). These orders will be implemented after the retirement of present incumbent on 31st January,2024. The representation of the petitioner is considered and disposed of accordingly.
