The petitioner has further stated that her husband is working in Indian Army and presently posted at Kupwara in Jammu & Kashmir, As such there is no one of the family to look after the old and ailing mother in law—father and one minor son.

From the perusal of the record, it reveals that Smt.Sonam Kumari, TGT, (Med) was transferred from GSSS Suri Distt. Una to GHS Banona u/c GSSS Wasni Distt. Sirmour with the prior approval of the competent authority after completion of her normal tenure at the present place of posting. Hence, keeping in view her family circumstances and the fact that her husband is serving the nation in difficult areas in Indian Army. In view of clause 5.2 Comprehensive Guiding Principles-2013, Smt. Sonam Kumari, TGT (Med) is hereby transferred / adjusted in GHS Kanjian Distt. Hamirpur vice Sh.Neeraj Nishal, TGT (Med) (by clubbing his previous stay), with TTA/JT. With these observations the representation of the petitioner is considered and disposed of accordingly.
