

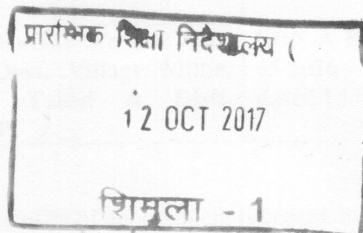




**Annexure-A**

**Terms and Conditions of Appointments**

1. He/She shall have to produce the following documents at the time of his/her joining:-
  - i) Medical fitness certificate from the C.M.O. concerned.
  - ii) Attested copies of Education Qualification Certificates.
  - iii) Character Certificate from a Gazetted Officer.
  - iv) Bonafide Himachali Certificate.
  - v) Certificate to this effect that he belongs to SC/ST/OBC, category, if any.
  - vi) Minimum Education Qualification Certificate i.e. Plus Two Certificate.
2. The candidate will have to furnish a declaration to the effect that in case of his/her married status, he/she is having a one living spouse.
3. The candidate will have to furnish a certificate in proof of his/her date of birth.
4. Wages @252/- per day (as per instruction issued by the Govt. from time to time) shall be admissible to his/her.
5. That the candidate will have to give an undertaking in writing that he/she was never convicted by any court of Law and if so, then he/she will have to furnish details regarding offence committed and punishment thereof. In case of concealing of facts, his/her services are liable for termination.
6. The candidate will have to take an oath of allegiance faithfulness to the constitution of India.
7. He will be entitled of Leave etc. as per norms of Daily Wager.
8. Provisions of service rules like FRSR, leave Rules, GPF Rules, Pension Rules and Conduct Rules etc. as are applicable in case of regular employees will not be applicable in case of Daily Wage appointees.
9. The Head of Institutions/offices will ensure to provide them 'induction course' at HIPA immediately after joining.
