Whereas, Sh. Sanjeev Kumar, TGT (NM) who is u/t from GMS Kitpal u/c GSSS Sera (Hmr.) to GMS Pat u/c GSSS Kashapat Distt. Shimla has filed CWP No. 742/2021 titled as Sanjeev Kumar, TGT (NM) Vs. State of H.P. before the Hon'ble High Court of H.P. The case of the petitioner was listed before the Hon'ble High Court Himachal Pradesh on 12.02.2021 when after hearing the matter the Hon'ble High Court has directed as under:-

"Consequently; the instant writ petition is disposed of by permitting the petitioner to represent before respondent No. 2 within a period of one week from today seeking his adjustment elsewhere and in turn the representation so made by the petitioner shall be considered and decided on its merit by respondent No. 2 in accordance with applicable transfer policy within two weeks thereafter. Till such time, petitioner shall not be compelled to join at the transferred station and he may be permitted to avail leave of kind due. Pending."

The department has received representation of Sh. Sanjeev Kumar, TGT (NM) who is u/t from GMS Kitpal u/c GSSS Sera (Hmr.) to GMS Pat u/c GSSS Kashapat Distt. Shimla. On perusal of the record, it is found that the petitioner is working in GMS Kitpal u/c GSSS Sera (Hmr.) since 23.08.2006 on PTA basis and his services were regularized on 20.08.2020 meaning thereby that he has completed about fourteen years six months stay i.e GMS Kitpal u/c GSSS Sera (Hmr.).

The petitioner vide representation dated 3.3.2021 has requested for adjustment in the following schools:-

- GMS jamog u/c GSSS Mandhorghat (SML)
- GHS Dhalli u/c GSSS Piran (SML)
- GMS Shilla u/c GSSS Bagalti (SML)
- GHS Kharkhan (SML)
- GHS Jabri (SML)

Presently there is vacancy of TGT NM only in GMS Shilla u/c GSSS Bagalti (SML).

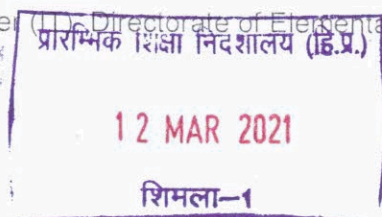
