

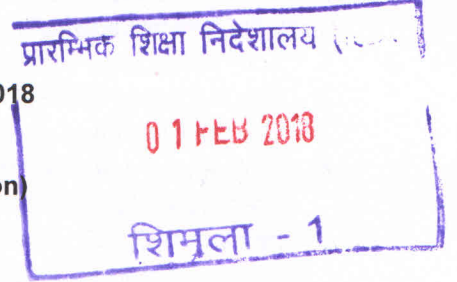

Subject:-

Verification of monthly FCI bills of foodgrains (Rice) actually lifted by the HPSCSC from FCI Godowns for the payment of cost of Foodgrains (Rice) under Mid Day Meal Scheme.

Sir/ Madam,

As you are already aware that the foodgrains(Rice) is allocated on quarterly basis to the Districts on the basis of beneficiaries for the implementation of Mid Day Meal Scheme. The foodgrains (Rice) is further allocated Block wise by the Districts on monthly basis for which the authorization letter is issued by the concerned Deputy Commissioners to the FCI and accordingly release orders are issued by the FCI. Thereafter, the foodgrains(Rice) is lifted by the transportation agency i.e. HPSCSC from FCI Godowns on monthly basis and transported upto PDS Depots from where the foodgrains(Rice) is lifted by the concerned schools. The copy of the Foodgrains (Rice) lifted by HPSCSC from FCI Godowns is supplied by FCI to your Districts on monthly basis and the payment of cost of lifted foodgrain(Rice) from FCI Godowns by the HPSCSC is made to the FCI on monthly basis by the Department of Elementary Education on or before 10th of every month .


In view of the above, it has been decided that before making the payment of cost of actually lifted Foodgrains (Rice) to FCI on monthly basis by the Department, the Deputy Directors (Elementary Education) should verify the FCI bills on month to month basis. Therefore, in order to reconcile the FCI bills the lifting position of foodgrain (Rice) for that particular month should be obtained from the concerned Area Managers of HPSCSC. This process should be completed in a time bound manner and furnished to this Directorate by 5th of every month positively on the following format.

In this context, you are ~~further~~ directed that lifting of foodgrain(Rice) from HPSCSC on behalf of Elementary Education Department should also be tallied / cross checked with reports being sent by Block Elementary Education officers of the Districts, so that discrepancy if any found may be removed at the early stage. You are also directed to furnish this information to this Directorate within stipulated period so that payment to FCI could be released on or before 10th of every month accordingly.
