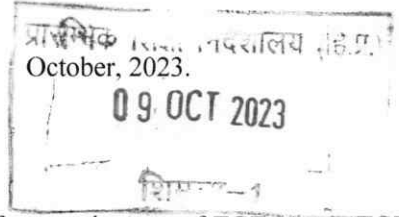



13	Age limit	<p>Between 18 and 45 years.</p> <p>(1) Age limit for direct recruitment will be reckoned on the first day of the year in which the post(s) are advertised for inviting applications or notified to the Employment Exchange or as the case may be.</p>
