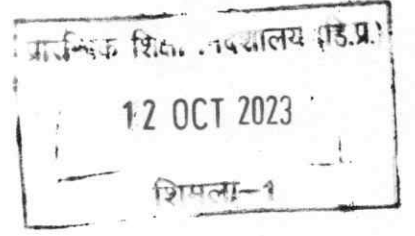

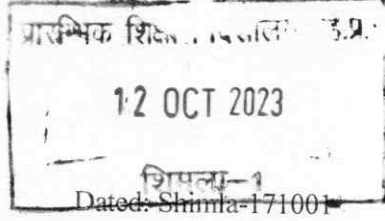
3) The appointment of JBTs will be made purely on the basis of existing R&P Rules read with the NCTE norms and guidelines issued from time to time (Govt. instructions vide letter No. EDN-C-A (3)-1/2016-Vol-I dated 27.09.2023).


4.	Any other information.	i) The batch-wise merit/inter-se-seniority of a particular batch shall be determined on the basis of marks obtained in the diploma/course of Junior Basis Teacher (by whatever name known). In case, the marks obtained in diploma/course by two or more candidates are same, the inter-se-merit would be decided on the basis of marks obtained in 10+2 level and if there is still a tie, the candidate senior in age would be placed above the junior in the merit/inter-se-seniority. In case the candidates have same score, the candidate senior in age would be placed above the junior in the merit.

8) The candidates shall be allotted District as per his/her rank in the overall merit list read with the order of preference of the candidates. The allotted District will be displayed on the website of DEE. Merely listing of name in the shortlist drawn at District level or overall merit list drawn at Directorate level does not confer any right to the candidate for posting. The appointment shall be made after verification of documents in support of the eligibility criteria. **The draft of the appointment letter shall be uniform throughout the State and the**

specimen shall be shared by the Directorate shortly. The BEEOs concerned shall take the joining after verification of documents.
