ORDER

In the matter of: CWP No. 6928/2023-titled as Desh Raj, TGT (Arts) V/s State of Himachal Pradesh (Regarding Transfer).

Sh. Desh Raj, TGT (Arts) has filed CWP No. 6928/2023 in the Hon'ble High Court of Himachal Pradesh, who is under transfer from GSSS Khini District Mandi to GHS Jawalpur u/c GSSS Kot-Sanore, District Mandi vice Sh. Jayoti Prakash, TGT (Arts) vide which seeking the relief to the extent that the petitioner transfer order may be cancelled or adjusted in District Hamirpur in soft station in view of family circumstances.

From perusal of the record it reveals that the petitioner Sh. Desh Raj, TGT (Arts) was transferred from GSSS Khini District Mandi to GHS Jawalpur u/c GSSS Kot-Sanore, District Mandi vice Sh. Jyoti Prakash, TGT (Arts) and vice versa basis, with TTA/JT after completion of his normal tenure, with the prior approval of the competent authority, where he was working since 22-09-2018 and has completed normal tenure at his present place of posting. On 28.09.2023 Sh. Desh Raj, TGT (Arts) has already joined his duty at GHS Jawalpur u/c GSSS Kot-Snore, District Mandi and at present post of TGT (Arts) are not lying vacant in District Hamirpur.

Keeping in view, the above facts and circumstances, the case of the petitioner for adjustment cannot be considered at this stage as the petitioner has already ~~been~~ joined at transferee school. Hence, request made by the petitioner is hereby rejected. The representation of the petitioner is disposed of accordingly.
