In the matter of: CWP No. 4939/2023 -titled as Santosh Kumar, Vs. State of H.P. & Others.

Whereas, Sh. Santosh Kumar, TGT (NM) preferred CWP No. 4939/2023 titled as Santosh Kumar, TGT(NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding his transfer from GMS Swar, U/C GSSS Lohardi (Chhota Bhangal) Sub Cadre area in Distt. Kangra to Soft area in Distt. Mandi and Kangra. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 01-08-2023 when the Hon'ble High Court has passed the following orders:-

" 5. In view of the above submissions, the instant writ petition is disposed of by permitting the petitioner to make a fresh representation to the competent authority / respondent No. 2 within a week from today, who shall in turn, consider and decide the same, in accordance with law and applicable transfer policy, within a further period of three weeks by passing a reasoned order, which shall also be communicated to the petitioner. Pending miscellaneous application(s), if any, shall also stand disposed of.

In the compliance the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 23-08-2023. He attended the same and submitted his representation in this office on 23-08-2023 vide which he has requested that he has completed required tenure at his present place of posting i.e GMS Swar, U/C GSSS Lohardi , Distt. Kangra and he further requested that he may be transferred to soft area in Distt. Mandi and Distt. Kangra, H.P, against vacancy being caused due to promotion of TGT to Lecturers in near future.

Whereas, from perusal of record, it has been found that the petitioner is working at GMS Swar, U/C GSSS Lohardi, Distt. Kangra w.e.f. **06-02-2014** and has completed 9 years and 6 months tenure at present place of posting. However, stations of his choice are not vacant at this stage. Therefore, after careful examination, the representation of the petitioner is rejected on administrative grounds.
