He attended the same and submitted his representation in this office on 04-10-2023 vide which he has requested that he has completed required tenure at his present place of posting i.e GMS Barkal, U/C GHS Munish, Distt. Shimla and he further requested that he may be transferred to nearby home station in Distt. Hamirpur and Distt. Bilaspur, H.P, against vacancy being caused due to promotion of TGT to Lecturers in near future.

Whereas, from perusal of record, it has been found that the petitioner is working at GMS Barkal, U/C GHS Munish, Distt. Shimla w.e.f. 25-11-2019 and has completed three years stay at present place of posting. However, stations of his choice are not vacant at this stage. Therefore, after careful examination, the representation of the petitioner is rejected on administrative grounds.

The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 28-07-2023 when the Hon'ble High Court has passed the following orders:-

"5. In view of the innocuous Prayer by learned counsel for the petitioner and without examining the merits of the matter, this writ petition is disposed of with a direction to the respondent No. 2/ competent authority to consider and decide the fresh representation to be filed by the petitioner within four days from today by passing appropriate orders in accordance with law, within a period of two weeks thereafter. Thereafter, the decision so arrived at shall also be communicated to the petitioner. Pending miscellaneous application(s), if any, shall also stand disposed of.

In the compliance the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 23-08-2023. He attended the same and submitted his representation in this office on 23-08-2023 vide which he has requested that he has completed required tenure at his present place of posting i.e GSSS Piran, Distt. Shimla and he further requested that he may be transferred to nearby home station in Distt. Kangra, H.P, against vacancy being caused due to promotion of TGT to Lecturers in near future.

Whereas, from perusal of record, it has been found that the petitioner is working at GSSS Piran, Distt. Shimla w.e.f. August, 2018 and has completed three years stay at present place of posting. However, stations of his choice are not vacant at this stage. Therefore, after careful examination, the representation of the petitioner is rejected on administrative grounds.


