ORDERO.

In the matter : CWP No. 9115/2023 titled as Smt. Jyoti Banyal,TGT(Med), VS State of H.P. & others.

The Petitioner, Jyoti Banyal,TGT(Med)) filed CWP No. 9115/2023 titled as, Smt. Jyoti Banyal,TGT (Med) Vs State of H.P. before the Hon'ble High Court of H.P. against her transfer from GSSS Sanahal (Una) to GSSS Baliwal Distt. Una.The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 20th November.2023, when after hearing the matter,the Hon'ble High Court has disposed of the same with the following directions/ order:-

" Learned counsel for the petitioner fairly submits that private respondent No.4. has joined in place of the petitioner on the basis of communication dated 17th Nov.2023,Annexure P-2,therefore ,this court is not inclined to stay the operation of the aforesaid orders.However,this Court directs respondent No.1 to 3,not to compel the petitioner to join t he transferred station at GSSS Baliwal(Una) and the petitioner may avail leave of the kind due till the decision of the representation ,as aforesaid.

Needless to say that ,this Court has not averted to the rival contentions and merits of the matter and all the Question of facts and law are left open.

As aforesaid ,all the writ petition s as well as the pending miscellaneous application(s),if any shall also stand disposed of,accordingly."

As per direction of the Hon'ble High Court the petitioner submitted her representation to the undersigned, in which she has requested that she may be adjusted against the person having longer stay in GSSS Balh/GSSS Bhadoli Dsitt. Una .She has also further stated that she is a single lady who was to look after her old ailing mother in law.

From the perusal of the record, it reveals that Smt. Jyoti Banyal TGT,(Med) was transferred from GSSS Sanahal (Una) to GSSS Baliwal (Una) with the prior approval of the competent authority after completion of her normal tenure at the present place of posting . I find it appropriate to transfer the petitioner to GSSS Balh (UNA) vice Smt. Balwinder Kaur,TGTMed) Distt.Una, with TTA/JT. With these observations the representation of the petitioner is considered and disposed of accordingly.

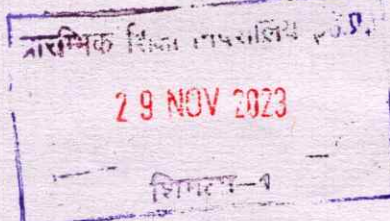
