The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 12.10.2023 when the Hon'ble High Court has passed the following orders:-

"4. In view of the above submissions, the representation, Annexure P-3, does not appear to be strictly in terms of the transfer policy as the choice stations have not been detailed therein. In these circumstances, the petitioner is permitted to submit a fresh representation to respondent No.2 within one week from today, detailing therein stations of her choice, strictly in terms of the transfer policy and on receipt of such representation, respondent No. 2, will decide and consider the same within two weeks thereafter, strictly in terms of the transfer policy. The petition is accordingly disposed of, so also the pending miscellaneous application(s), if any."

In compliance of the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 20.11.2023. She has not attended the same and submitted her representation through Advocate in this office on 20.11.2023 vide which She has requested that She has completed required tenure at her present place of posting at GMS Hibra, u/c GSSS Gehra, Distt. Chamba and She further requested that She may be transferred to GHS Ladwara u/c GSSS Rait, GSSS Bagli, GSSS (Girls) Dharamshala, GMS Sudher u/c GSSS Gharoh, GHS Bhagsunag u/c GSSS Fursythganj, GMS Samela u/c GSSS Old Kangra, Distt. Kangra, and GSSS Tundi, Distt. Chamba, against vacancy/ longer stayee. She has given five stations of her choice in the aforesaid representation.

Whereas, from perusal of record, it has been found that the petitioner is working at GMS Hibra, U/C GSSS Gehra, Distt. Chamba hard / difficult area w.e.f. 23-11-2019 and has completed the normal tenure of three years. At present there is no post of TGT (NM) lying vacant in schools given by the petitioner in her representation. One Sh. Milant Dogra TGT(NM) is working in GSSS Bagli, Distt. Kangra since 20-01-2023. The petitioner has requested in her representation that She may be transferred to GSSS Bagli, Distt. Kangra, against longer stayee. Keeping in view of the above position, the representation of the petitioner is considered sympathetically and She is hereby transferred from GMS Hibra, U/C GSSS Gehra, Distt. Chamba, to GSSS Bagli, Distt. Kangra, vice Sh. Milant Dogra, TGT(NM) by clubbing his previous stay, with TTA/JT to Sh. Milant Dogra, TGT(NM). The representation of the petitioner is disposed of accordingly.
