Whereas, Sh. Vikram Singh, TGT (NM) preferred CWP No. 8789/2023 titled as Vikram Singh, TGT(NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding his transfer from GMS Koon, U/C GSSS Balag, Distt. Mandi to nearby home station in Distt. Mandi. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 08-11-2023 and 04-12-2023 when the Hon'ble High Court has passed the following orders:-

"4. In view of this, the respondents are directed to examine the case of the petitioner for posting either against vacancy or longer stay, as mentioned in pera-6 and pera-8(i) as well as the vacant stations mentioned in Annexure P-5, of the writ petition."

In compliance of the aforesaid orders of the Hon'ble High Court the petitioner has requested that he has completed required tenure at his present place of posting at GMS Koon, U/C GSSS Balag, Distt. Mandi and he further requested that he may be transferred to GMS Behli, u/c GSSS Mahadev, Distt. Mandi, against vacancy.

Whereas, from perusal of record, it has been found that the petitioner is working at GMS Koon, U/C GSSS Balag, Distt. Mandi w.e.f. 16-11-2019 and has completed three years stay at present place of posting. However, stations of his choice in para-6 of writ petition is not vacant at this stage. Therefore, after careful examination, it is decided that since the Department of Higher Education is going to make promotions to the post of School Lecturer (New) from amongst the eligible Trained Graduate Teachers in near future, hence the petitioner will be given posting at a suitable place as and when the vacancy arises. The representation of the petitioner is rejected and disposed of accordingly.
