However, the respondents shall permit the petitioner to avail leave of kind due till the decision of the representation.

Needless to say that ,this Court has not adverted to the rival contentions and merits of the matter and all questions of facts and law are left open.

In aforesaid terms, the writ petition a well as the pending miscellaneous application(s), if any shall also stand disposed of, accordingly."

As per direction of the Hon'ble High Court the petitioner was called for personel hearing on dated 12<sup>th</sup> December,2023. The petitioner attended the personal hearing on scheduled date and time. During personal hearing she has requested that she may be allowed to remain in previous school. The petitioner has further stated that her husband is working a out of State. As such there is no one of the family to look after my old ailing father in law who is suffering from various old age ailments.

From the persual of the record, it reveals that Smt. Balwinder Kaur, TGT (Med) has been transferred from GSSS Balh Distt. Una to GHS Gagoh (UNA) after completion more than eight years stay in present place of posting i.e. (19<sup>th</sup> January, 2016), Moreover, in GHS Gagoh Distt. Una, there are 72 students studying from class VI to X. In the interest of the students post of TGT (Med) cannot be kept vacant. Therefore, keeping in view of the position stated above, the representation made by the petitioner can not be acceded to and hereby rejected and disposed of accordingly.
