Whereas, Snt. Neeru Bala Sharma, TGT (NM) preferred CWP No. 5178/2023- titled as Neeru Bala Sharma, TGT (NM) Vs. State of H.P & others before the Hon'ble High Court of H.P. regarding her transfer from GHS Panihar, U/C GSSS Thatibir, Distt. Kullu to Distt. Hamirpur and Distt. Una, against vacancy or longer stayee. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 20-09-2023 when the Hon'ble High Court has passed the following orders:-

*"Accordingly, the petition is disposed of with the directions to respondents NO. 1 and 2 to consider the representation of the petitioner within four weeks from the date of passing of this order and decide the same by passing a speaking order. Accordingly, the petition is disposed of. Pending miscellaneous applications, if any, stands disposed of."*

In compliance of the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 20-11-2023. She attended the same and submitted her representation in this office on 20-11-2023, vide which She has requested that She has completed required tenure at her present place of posting at GHS Panihar, U/C GSSS Thatibir, Distt. Kullu, H.P and She further requested that She may be transferred to nearby in Distt. Hamirpur and Distt. Una, against vacancy/ longer stayee.

Whereas, from perusal of record, it has been found that the petitioner is working at GHS Panihar, U/C GSSS Thatibir, Distt. Kullu, H.P w.e.f. 04-12-2019 and has completed the normal tenure of three years. One Sh. Rakesh Kumar TGT(NM) working in GSSS Mehal, Distt. Hamirpur since 21-09-2022. The petitioner has given willingness for her transfer to the aforesaid school against longer stay. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetically, and She is hereby transferred without TTA from GHS Panihar, U/C GSSS Thatibir, Distt. Kullu, H.P to GSSS Mehal, Distt. Hamirpur, vice Sh. Rakesh Kumar, TGT(NM) by clubbing his previous stay, with TTA/JT to Sh. Rakesh Kumar, TGT(NM). The representation of the petitioner is disposed of accordingly.

Whereas, Sh. Amit Sharma, TGT (NM) preferred in CWP No. 6364/2023- titled as Amit Sharma, TGT (NM) Vs. State of H.P. & Ors. before the Hon'ble High Court of H.P. regarding his transfer from GSSS Daya, Distt. Sirmour sub-cadre difficult area to soft area in Distt. Kangra, against Longer stayee/ clubbing his stay. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 13.09.2023 when the Hon'ble High Court has passed the following orders:-

Kangra against longer stayee/clubbing.

Whereas, from perusal of record, it has been found that the petitioner is working at GSSS Daya, Distt. Sirmour sub-cadre difficult area w.e.f. 25.02.2021 and has completed the normal tenure and entitled for his transfer to the station of his choice as per policy. One Shri Arun Kumar, TGT (NM) working in GMS Bhatllu u/c GSSS Daroh, Distt. Kangra since 24.02.2023. The petitioner has given willingness for his transfer to the aforesaid school against longer stay by clubbing. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetically, and he is hereby transferred without TTA from GSSS, Daya, Distt. Sirmour to GMS Bhatllu u/c GSSS Daroh, Distt. Kangra, vice Sh. Arun Kumar, TGT (NM) by clubbing his previous stay, with TTA/JT to Shri Arun Kumar, TGT (NM). The representation of the petitioner is disposed of accordingly.
