ORDER

In the matter :

CWP No.8453/2023 titled as Anamika,TGT(Med) VS state fo H.P. & others.

The Petitioner Smt.Anamika TGT(Med) filed CWP No. 8453/2023 titled as Smt. Anamika versus State of H.P. before the Hon'ble High Court of H.P. against her transfer from GSSS Ghumarwin (BLP) to GSSS Dhawal (MND) vice Smt. Gagan Lata ,TGT(Med).The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 15<sup>th</sup> December 2023,when after hearing the matter the Hon'ble High Court has disposed of the same with the following directions/ order:-

*In terms of previous orders dated 21-11-2023,learned counsel for the the petitioner submits that request for transfer on mutual basis has been made to the respondent No.2-Director of Elementry Education,Himachal Pradesh ,on which no action has been taken,in spite of the earlier orders.*

*Mr.Vishal Panwar,Learned State Counsel prays for ans is granted a week's time to have fresh instructions .*

*It is clarified that ,in case ,there is no legal impediment,the appropriate consideration orders may be passed on the aforesaid request."*

From the perusal of the record, it reveals that Smt.Anamika,TGT(Med) (Petitioner ) has been transferred from GSSS Ghumarwin (BLP) to GSSS Dhawal (MND) vice Smt. Gagan Lata ,TGT(Med), with the prior approval of the competent authority dated. 31<sup>st</sup> October,2023,(as she is working within the raiodius of 30 Km), she has further joined in GSSS Dhawal(MND) dated 08<sup>th</sup> November,2023.At present she has not completed her normal stay at GSSS Dhawal Distt. Mandi, hence , she cannot be transferred from there as per transfer policy .Moreover, there is complete ban on transfer. Keeping in view position state above representation of the petitioner is considered and hereby rejected.

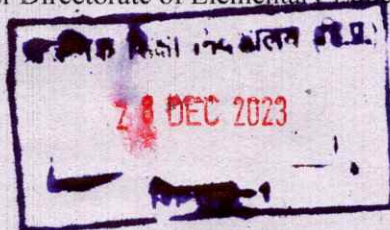
