Keeping in view of the position stated above, the request of the petitioner is considered sympathically and petitioner Sh. Arun Kumar, TGT(NM) who is under order of transfer from GMS Bhatilli, U/C GSSS Daroh, Distt. Mandi to GSSS Daya, Distt. Sirmour is hereby adjusted without TTA/JT at GMS Tikker, U/C GSSS Ather, Distt. Chamba, H.P., against vacancy. The representation of the petitioner is disposed of accordingly.
