Whereas, Sh. Kamal Kumar, TGT (NM) preferred CWP No. 9861/2023 titled as Kamal Kumar Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GMSSS Sainj District Kullu to the station nearby his native place Distt. Kangra against vacancy/ longer Stayee. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 12.12.2023 when the Hon'ble High Court has passed the following orders:-

*" 8. Without going into the merits of the hardships, if any, this Court, disposes of, the instant writ petition, by directing the Respondent No. 2 Director of Elementary Education, Himachal Pradesh, to decide the representation and to make an effort to redress the hardship(s), if any, by passing appropriate orders in accordance with law, by taking into account the norms governing transfers and also the mandate of law in case of Shilpi Boas and Gobardhan Lal (supra) within two weeks thereafter."*

In compliance of the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 04-01-2024. He has attended the same and submitted his representation in this office on 04-01-2024 vide which he has requested that he has completed required tenure at his present place of posting i.e GMSSS Sainj District Kullu, H.P and he further requested that he may be transferred to Distt. Kangra, against vacancy/ longer stayee by clubbing his/her previous stay. Petitioner has given five stations of his choice in District Kangra.

Whereas, from perusal of record, it has been found that the petitioner is working at GMSSS Sainj District Kullu w.e.f. 14.08.2018 and has completed more than three years stay at present place of posting. One Sh. Subhash Chand TGT (NM) is working in GHS Ghaneta u/c GSSS Darang, Distt. Kangra since 28-05-2021. The petitioner has given willingness for his transfer to the aforesaid school against longer stay. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetically, and he is hereby transferred without TTA from GMSSS Sainj, Distt. Kullu to GHS Ghaneta u/c GSSS Darang, Distt. Kangra, vice Sh. Subhash Chand, TGT (NM) by clubbing his previous stay, with TTA/JT to Sh. Subhash Chand, TGT (NM). The representation of the petitioner is disposed of accordingly.
