The Petitioner,Smt. Anuradha,TGT(Med),filed CWP No. 1797/2024 titled as, Smt. Anuradha, Vs State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from GSSS Chobia (Bharmour),Distt. Chamba (which fall under hard /Tribal area) to his choice of station after the completion of required tenure as per policy. The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 11<sup>th</sup> March,2024 Nov. 2023, when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/ order:-

"In view of the above, the Writ petition is disposed of with the direction that in the event of the petitioner filling an appropriate representation to the competent Authority for to her transfer outside the sub-cadre area by speciflying therein the station which as per her lying vacant said representation be decided by the Competent Authority within a period of four weeks as from the dated of the receipt thereof and if possible, the petitioner be adjusted at a station of her choice in case any such station is indeed vacant."

In above matter the petitioner's representation was received in this office on dated 18<sup>th</sup> March,2024. In her representation the petitioner has requested that she may be adjusted in GHS Khian Patt u/c GSSS Rajpur (KGR)/ GHS Pantehar u/c GSSS Rajpur/ GSSS Dola Kharyana/ GHS Menjha Distt. Kangra/ GSSS Chabutra Distt. Hamirpur against vacancy or by clubbing of stay within radious of 30 Kms.

From the perusal of the record, it reveals that Smt. Anuradha, TGT(Med), is presently working in GSSS Chobia (Bharmour), Distt. Chamba (which fall under hard /Tribal area) since 26<sup>th</sup> February 2021 and has completed her normal tenure at present place. I find it appropriate to transfer the petitioner to GHS Khianpatt (KGR) vice Smt. Monika Katna, TGT (Med) (by clubbing her previous stay), with TTA/JT. With these observations the representation of the petitioner is considered and disposed of accordingly.
