ORDER.

CWP No. 2325/2024 titled as Vandana Sharma, TGT(Med) VS State of H.P. & others.

The Petitioner, Smr. Vandana Sharma, TGT (Med)) filed CWP No.

2325/2024 titled as, Smt. Vandana Sharma, TGT (Med) Vs State of H.P. before the Hon'ble High Court of H.P. against her transfer from GHS Narayani u/c GSSS Pratha (SLN) to GSSS Kawarag Distt. Solan. The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 20<sup>th</sup> March. 2024, when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/order:-

"Accordingly, without interfering with the impugned transfer order, this petition is disposed of with the direction that in the event of the petitioner filing a representation for her adjustment at some other nearby station within a period of one week from today, then let said representation be decided by the competent Authority sympathetically, taking into consideration the fact that the petitioner happen to be be single parent, having two school going children and an endeavour be made for her adjustment at some nearby station in terms of the in term of the contents of the representation, within a period of three weeks as from the date of receipt thereof. Till then, the petitioner shall not be forced to join at the new place of posting and she is at liberty to avail kind of leave due to her. Pending miscellaneous application(s), if any also stand disposed of accordingly."

As per direction of the Hon'ble High Court the petitioner submitted her representation to the undersigned, in which she has requested that she may be adjusted against vacancy in GHS Nehri-Kalan Distt. Solan. The petitioner further stated due to her adverse family circumstances she may be posted closer to his home.

From the perusal of the record, it reveals that Smt. Vandana Sharma, TGT, (Med) was transferred from GHS Narayani u/c GSSS Pratha (SLN) to GSSS Kawarag Distt. Solan with the prior approval of the competent authority after completion of her normal tenure at the present place of posting .I find it appropriate to transfer the petitioner to GHS Neri-Kalan Dsitt. Solan against vacancy without TTA/JT. With these observations the representation of the petitioner is considered and disposed of accordingly.
