## <u>ORDER</u>

Smt. Poonam Gautam, TGT (Arts) has filed CWP No. 2392/2024 titled as Poonam Gautam V/s State of H.P. in the Hon'ble High Court, as she is u/t from GBSSS, Nahan District Sirmour to GSSS, Chhogtali Distt. Sirmour vice Ekta Dhiman Distt (Smr.) and now seeking her adjustment at GHS Nalka, U/c GBSSS, Bankala Distt. (Smr.) against vacancy. The case was decided before the Hon'ble High Court of H.P. on 21.03.2024, on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under:-

That being so, though no relief can be granted to the petitioner in the instant petition, yet he is permitted to submit a representation to the competent authority, detailing the instances of his individual hardships. On receipt of such representation, the competent authority is expected to decide the same expeditiously and in any case not later then four weeks.

In compliance to the aforesaid orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner i.e Smt. Poonam Gautam, TGT (Arts) has submitted fresh representation and sought her adjustment to GHS, Nalka u/c GSSS, Bankala Distt. Sirmour against vacancy due to her adverse family circumstances.

From the perusal of record, it is found that Smt. Poonam Gautam, TGT (Arts) was working at GBSSS, Nahan Distt. Sirmour since October 2020. At present one post of TGT (Arts) is lying vacant in GHS; Nalka u/c GSSS, Bankala Distt. Sirmour.

Keeping in view the position stated above, representation of the petitioner i.e Smt. Poonam Gautam, TGT (Arts) is considered sympathetically and petitioner is hereby adjusted at GHS, Nalka u/c GSSS, Bankala Distt. Sirmour without TTA/JT. The representation of the petitioner is disposed of accordingly:
