OFFICE ORDER

In the matter of:-

CWP No. 2029/2024 titled as Raj Kumar V/s State of H.P.

Whereas, Sh. Raj Kumar, TGT (NM) earlier preferred CWP No. 2029/2024 titled as Raj Kumar Vs. State of H.P. before the Hon'ble High Court of H.P. against his transfer from GSSS, Bhager Distt. Bilaspur to GHS Anech u/c GSSS, Bohli Distt. Solan vice Sh. Manohar Lal, TGT (NM). The above writ petition was listed before the Hon'ble High Court on dated 15.03.2024 on this day Hon'ble Court has passed the following orders:-

"3. The petition is accordingly disposed of with the observation that in case any such representation is made by the petitioner within a period of one week from today, then, the same be disposed of by the Competent Authority within a period of three weeks as from the date of the receipt thereof and appropriate orders be passed thereupontaking into consideration the physical condition of the petitioner. Till then the petitioner shall not be forced to join at a new place of posting and he shall be at liberty to avail the leave of kind due. Pending miscellaneous application, if any, also stand disposed of".

In the compliance with the aforesaid orders of the Hon'ble High the petitioner has submitted high peresentation in this office on 18-03-2024, vide which he has requested that he may be transferred/adjusted at GSSS Amarpur, District Bilaspur, H.P, against vacancy being caused due to retirement of present incumbent on 31-03-2024.

From perusal of record, it has been found that the petitioner has been working at GSSS Bhager, Distt. Bilaspur, H.P. w.e.f. 09-10-2020 and under transfer to GHS Anech, U/C GSSS Bohli, Distt. Solan. H.P. The aforesaid school falls in soft area. The post of TGT(NM) is lying vacant in GHS Anech, U/C GSSS Bohli, Distt. Solan and (79) students are studying in this school. Due to non-availability of TGT (NM) in the said school studies of students are suffering adversely. Moreover, TGT(NM) is State Cadre post and the incumbents supposed to serve anywhere in the State as per requirement and administrative exigency. Therefore, after critical examination and thoughtful application of mind the request made by the petitioner is hereby rejected on administrative ground and in larger public interest. The petitioner is hereby directed to join in GHS Anech, U/C GSSS Bohli, Distt. Solan, H.P. immediately. The representation of the petitioner is disposed of accordingly.


