OFFICE ORDER

In the matter of:- CWP No. 1273/2024 titled as Ripu Daman V/s State of H.P.

Whereas, Sh. Ripu Daman, TGT (NM) earlier preferred CWP No. 1273/2024 titled as Ripu Daman Vs. State of H.P. before the Hon'ble High Court of H.P. against his transfer from GSSS, Jhagriani, Distt. Bilaspur to GMS Standali, U/C GMSSS(Boys) Kotkhai, Distt. Shimla. The above writ petition was listed before the Hon'ble High Court on dated 02-04-2024 on this day Hon'ble Court has passed the following orders:-

"3. Accordingly, without interfering with the impugned transfer order, this petition is disposed of by permitting the petitioner to move an appropriate representation with the authority concerned for his readjustment at some other station in view of the fact that this is a couple case and in the event of any such representation being filed within three days from today, let the same be decided by the concerned authority within ten days from the date of receipt thereof. Till then the petitioner shall not be forced to join the place of transfer and he shall be at liberty to avail the kind of leave due to him. In other words, there is no impediment in the way of the private respondents No 3 and 4 in joining at the station where they stand transferred vide Office order dated, 22.02.2024".

In the compliance with the aforesaid orders of the Hon'ble High the petitioner has submitted his representation in this office on 05-04-2024, vide which he has requested that he may be transferred/ adjusted at GSSS Doghari, Distt. Mandi, H.P., against vacancy .

From perusal of record, it has been found that the petitioner has been working at GSSS Jhagriani, Distt. Hamirpur, H.P. and under transfer to GMS Standali, U/C GMSSS(Boys) Kotkhai, Distt. Shimla . The post of TGT(NM) is lying vacant in GSSS Doghari, Distt. Mandi, H.P. Due to non-availability of TGT (NM) in the said school studies of students are suffering adversely. Keeping in view of the position stated above, as per the direction of Hon'ble High Court he is hereby transferred/ adjusted without TTA/ JT from GSSS Jhagriani, Distt. Hamirpur, H.P. to GSSS Doghari, Distt. Mandi, H.P. against vacancy. The representation of the petitioner is disposed of accordingly.

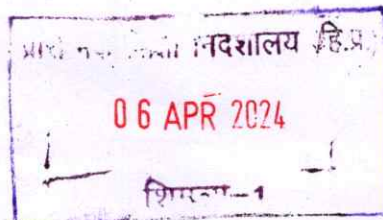
