Hence, the representation of the petitioner is considered sympathetically and she is herby transferred to GSSS Ghaniara vice Smt. Seema Pathania, TGT (Med), (by clubbing her previous stay), with TTA/JT. With these observations the representation of the petitioner is considered and disposed of accordingly.


