ORDER

In the matter of:

CWP No: 811/2024-titled as Naresh Kumar V/s State of Himachal Pradesh (Regarding Transfer).

Sh. Naresh Kumar, TGT (Arts) has filed CWP No. 811/2024 titled as Naresh Kumar V/s State of H.P. in the Hon'ble High Court, and seeking his transfer from GHS, Deval Tikkari u/c GSSS Kuji Distt. Sirmour against vacancy. The case was decided before the Hon'ble High Court of H.P. on 15-03-2024, on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under:-

"Accordingly, this petition is disposed of with direction that in the event of the petitioner filing a representation for his adjustment within one week from today, then the same shall be considered sympathetically and appropriate orders be passed thereupon by the competent authority within a period of four weeks as from the date of receipt of the representation.

The petition stands disposed of in above terms. Pending miscellaneous application(s), if any also stand disposed of accordingly.

In compliance to the aforesaid orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner i.e Sh. Naresh Kumar, TGT (Arts) has attended the personal hearing on 05.04.2024 and submitted fresh representation and stated that GHS, Deval Tikkari u/c GSSS Kuji Distt. Sirmour is 170 Km. away from his native place and his mother is kidney tumor patient and is under treatment in AIIMS Bilaspur. He is the only son to look after her, so he requested that he may kindly be transfer either to GSSS, Saryanj Distt. Solan/ GHS, Dadaoh u/c GSSS, Kharkari Distt Bilaspur/GSSS, Bagheri Distt. Solan.

From the perusal of record, it is found that Sh. Naresh Kumar, TGT (Arts) was transferred from GSSS (G) Ghumarwin (BLP) to GHS, Deval Tikkari u/c GSSS Kujji Distt. Sirmour vice-versa basis by clubbing his previous stay on 17.01.24 and joined at GHS, Deval Tikkari Distt. (Smr.) on 20.01.2024 having short stay at present place of posting. He has requested that he may kindly be adjusted at GSSS Saryanj (Solan). At present three TGTs working at GSSS Saryanj and students enrolment is 98. A representation has been received regarding fill up the post in GMS Kadyah u/c GSSS, Danoghat in District Solan due to single teacher and students enrolment is 22.

3. Mandi to GHS, Bhareri Distt. (Sml.) which is far away from her home town and on the ground of couple case as per provision in Clause 5.4 of Comprehensive Guiding Principles 2013 adjust her at GSSS, Kamand Distt. (Mandi.).

Keeping in view the above said provision of transfer Policy, the representation of the petitioner is considered sympathetically and she is hereby adjusted at GSSS, Kamand Distt. (Mnd.) against vacancy, being a couple case. With these observations the representation of the petitioner is disposed of. All the concerned be intimated accordingly.
