Whereas, Sh. Pankaj Nag, TGT (NM) preferred CWP No. 1395/2024 titled as Pankaj Nag, TGT(NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding his transfer from GSSS Rathal, Distt. Shimla, H.P. to nearby home station in Distt. Kangra. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 28-02-2024 when the Hon'ble High Court has passed the following orders:-

"3. In view of the statement made by learned Deputy Advocate General, this writ petition is disposed of with a direction that let the petitioner be transferred from his present place of posting and if possible, he may adjusted at a station of his choice, taking into consideration the fact that he is serving in a remote rural area for a period of more than four years. The petition stands disposed of in above terms, so also pending miscellaneous application(s)."

In the compliance the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 05-04-2024. He attended the same and submitted his representation in this office, vide which he has requested that he has completed required tenure at his present place of posting i.e GSSS Rathal, Distt. Shimla, H.P and he may be transferred to nearby home station in Distt. Kangra, H.P against vacancy/ longer stayee by clubbing his/her previous stay .

Whereas, from perusal of record, it has been found that the petitioner is working at GSSS Rathal, Distt. Shimla, H.P w.e.f. 11-11-2019, and has completed the normal tenure of three years at present place of posting. One Sh. Bal Krishan, TGT(NM) is working in GHS Bandal, Distt. Kangra, H.P since 20-02-2021. The petitioner has given willingness for his transfer to the aforesaid school against longer stay by clubbing his previous stay. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetically, and he is hereby transferred without TTA from GSSS Rathal, Distt. Shimla, H.P to GHS Bandal, Distt. Kangra, H.P, vice Sh. Bal Krishan TGT(NM), against longer stay and by clubbing his previous stay within radius of 30 Kms., with TTA/JT to Sh. Bal kishan, TGT(NM). The representation of the petitioner is disposed of accordingly.

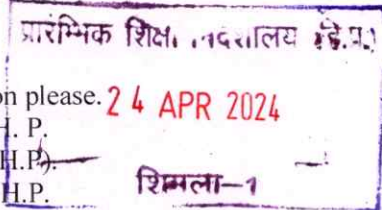
