In the matter of: CWP No. 1635/2024 -titled as Ajay Kumar Nag Vs. State of H.P. & Others.

Whereas, Sh. Ajay Kumar Nag, TGT (NM) preferred CWP No. 1635/2024 titled as Ajay Kumar Nag, TGT(NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding his transfer from GMS Ghurla U/C GSSS Bamta, Distt. Shimla, H.P. to nearby home station in Distt. Kangra. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 05-03-2024 when the Hon'ble High Court has passed the following orders:-

"3. The Petition, as agreed, is disposed of with the direction that let the representation of the petitioner (Annexure P-3) be decided by the Competent Authority within a period of six weeks from today. Pending miscellaneous applications, if any, also stand disposed of."

In the compliance the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 05-04-2024. He attended the same and submitted his representation in this office, vide which he has requested that he has completed required tenure at his present place of posting i.e GMS Ghurla U/C GSSS Bamta, Distt. Shimla, H.P and he may be transferred to nearby home station in Distt. Kangra, H.P against vacancy/ longer stayee by clubbing his/her previous stay .

Whereas, from perusal of record, it has been found that the petitioner is working at GMS Ghurla U/C GSSS Bamta, Distt. Shimla, H.P w.e.f. 03-12-2019, and has completed the normal tenure of three years at present place of posting. One Sh. Mann Singh, TGT(NM) is working in GSSS Daulatpur, Distt. Kangra, H.P since 10-01-2022. The petitioner has given willingness for his transfer to the aforesaid school against longer stay by clubbing his previous stay within radius of 30 Kms. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetically, and he is hereby transferred without TTA from GMS Ghurla U/C GSSS Bamta, Distt. Shimla, H.P. to GSSS Daulatpur, Distt. Kangra, H.P., vice Sh. Mann Singh, TGT(NM), against longer stay by clubbing his previous stay within radius of 30 Kms., with TTA/JT to Sh. Mann Singh, TGT(NM). The representation of the petitioner is disposed of accordingly.
