ORDER

In the matter of: CWP No: 2020/2024- Reena Devi Vs. State of Himachal Pradesh.

Smt. Reena Devi, TGT (Arts) has filed CWP No. 2020/2024 titled as Reena Devi TGT (Arts) seeking her transfer from GHS, Tuman u/c GSSS, Tebban Distt. (Mandi) against vacancy, likely to be created due to retirement of present incumbent working there on 30.04.2024 or GHS, Chokri u/c GSSS, Rajwari Distt (Mandi) against acancy. She is seeking her transfer on the ground of couple case. The case was decided before the Hon'ble High Court of H.P. on 15-03-2024, on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under :-

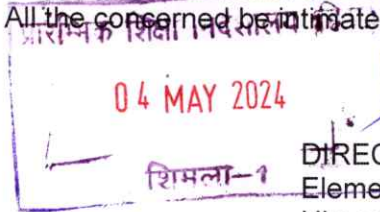
Accordingly, the instant petition is disposed f with a direction to respondent No.2 to decide the representation, Annexure P-1, already submitted by the petitioner, within two weeks from today by passing a detailed and reasoned order strictly in terms of clause 5.4 of the Comprehensive Guiding Principles, 2013, for regulating the transfer of the State employees.

Pending applications also stand disposed of.

In compliance to the aforesaid orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner i.e Smt. Reena Devi, TGT (Arts) has attended the personal hearing on dated 23.04.24 submitted fresh representation and stated that she has already completed her normal tenure at GHS Tuman u/c GSSS Tebban Distt. Mandi as she is working in the school since 24.02.2020 and her school is far away from her home. Her husband is working as a TGT (Arts.) in GSSS Phangwas Distt. Mandi So, being a couple she may be adjusted nearby her home town.

As per provisions contained in Para 5.4 of Office Memorandum No: Per (AP-B) (B) (7)-1/2010-Vol-II dated 17.9.2015 Comprehensive Guiding Principles 2013-for regulating transfers of officers/officials of the State Government dated 10.7.2013 in case wife and husband both are working under the State Government efforts should be made to post them at one place or near places as far as possible subject to vacancy.

Keeping in view the above said provision of transfer Policy, the representation of the petitioner is considered sympathetically and she is hereby transferred from GHS, Tumman U/c GSSS, Tebban Distt. Mandi to GSSS, Salwana Distt. Mandi against vacancy likely to be created due to retirement of present incumbent on 30.04.2024 without TTA/JT. Incumbent will join after 30.04.2024. With these observations the representation of the petitioner is disposed of. All the concerned be intimated accordingly.
